The Ministry of Foreign Affairs of the Republic of Singapore presents its compliments to the Ministry of Foreign Affairs of Mongolia, and has the honour to refer to the Ministry's Note. MFA/CON/01285/2016 dated 21 November 2016 and the latter's Note. A/114/2016 dated 1 November 2016, conveying the Government of Mongolia's proposal to upgrade the current visa waiver for nationals of either country holding valid travel documents to enter, leave, transit through and stay in the territory of the other country without visas, for purposes of tourism or business affairs, from a period not exceeding fourteen (14) days currently, to a period not exceeding thirty (30) days, on a reciprocal basis.

The Ministry has the honour to inform the Ministry of Foreign Affairs of Mongolia that the Government of the Republic of Singapore has no objections to the proposal of the Government of Mongolia to upgrade the visa exemption arrangement on a reciprocal basis, on the following conditions:

 Exemption of visas for nationals of both Mongolia and Singapore shall not exempt them from the obligations stated in the national laws and regulations of both countries, to enter, leave, transit through and stay in their respective territories;

This arrangement shall be implemented on a reciprocal basis thirty (30) days after the Ministry receives the Ministry of Foreign Affairs of

Mongolia's Note in reply;

• This Note, together with the Note of the Ministry of Foreigh Affairs of Mongolia in reply confirming its acceptance of this arrangement, shall constitute the agreement between both countries on the upgraded visa waiver arrangement.

The Ministry has the further honour to inform that nationals of Mongolia who hold valid travel documents are at present able to enter, leave, transit through and stay in the territory of Singapore without visas, for the

purposes of tourism or business affairs, for a period not exceeding thirty (30) days.

The Ministry awaits the Ministry of Foreign Affairs of Mongolia's Note in reply, confirming its acceptance of the above arrangement and date of implementation.

The Ministry of Foreign Affairs of the Republic of Singapore avails itself of this opportunity to renew to the Ministry of Foreign Affairs of Mongolia the assurances of its highest consideration.

The Ministry of Foreign Affairs of Mongolia presents its compliments to the Ministry of Foreign Affairs of the Republic of Singapore and in reply to your note MFA/CON/00513/2017 dated 8 May 2017 has the honour to convey for Ministry's consideration the following proposal to upgrade the current visa waiver for nationals of either country holding valid travel documents to enter, leave, transit through and stay in the territory of the other country without visas, for purposes of tourism or business affairs, from a period not exceeding fourteen (14) days to a period not exceeding thirty (30) days, on a reciprocal basis.

The Ministry has the honour to inform the Ministry of Foreign Affairs of the Republic of Singapore that the Government of Mongolia is accepting the proposal to upgrade the visa waiver arrangement on a reciprocal basis, on the following conditions:

- Exemption of visas for nationals of both Mongolia and Singapore shall not exempt them from the obligations stated in the national laws and regulations of both countries, to enter, leave, transit through and stay in their respective territories;
- This arrangement shall be implemented on a reciprocal basis thirty (30) days after the Ministry of Foreign Affairs of the Republic of Singapore receives the Ministry of Foreign Affairs of Mongolia's Note in reply;
- This note, together with the Note MFA/CON/00513/2017 of the Ministry of Foreign Affairs of the Republic of Singapore shall constitute the agreement between both countries on the upgraded visa waiver arrangement.

The Ministry has the further honour to inform that nationals of the Republic of Singapore who hold valid travel documents are at present able to enter, leave, transit through and stay in the territory of Mongolia without visas, for the purposes of tourism or business affairs, for a period not exceeding thirty (30) days.
